Mariners are advised that during operations on Neart na Gaoithe Offshore Wind Farm Limited (NnGOWL) a piece of equipment has been deposited on the seabed and forms a temporary hazard, until recovery is performed.

The equipment has been deposited at Wind Turbine Generator (WTG) location NNG-H17, within the boundaries of the Neart na Gaoithe (NnG) offshore wind farm area.

The deposit occurred during drilling and casing installation operations from the Saipem 7000. The S7000 has departed the Neart na Gaoithe (NnG) offshore wind farm area, however the location of the item is marked by a Guard Vessel (see pages 3-4) and an exclusion zone is implemented. Navigation warnings will be issued until the item is recovered.




Figure 1 – NnG Offshore Wind Farm Area

All vessels are requested to observe the exclusion area shown in Figure 1 and Table 2.
