Mariners are advised that during boulder clearance works, a Remotely Operated Vehicle (ROV) deployed from the *Sartor* has disconnected from its umbilical. The ROV is on the seabed within the boundaries of Neart na Gaoithe offshore wind farm, awaiting recovery, at the coordinates below. **The recovery will be performed by a separate vessel, the Kingdom of Fife (call sign: 2BKR2).** A 50-metre exclusion zone is advised around the ROV for safety reasons, until the ROV has been recovered from the seabed. A further Notice to Mariners will be issued once recovery is complete.

**Area of Operations**

The position of the seabed hazard is indicated by the coordinates in Table 1.
