Mariners are advised that Neart na Gaoithe Offshore Wind Farm Limited (NnGOWL) are due to transport two components of onshore project infrastructure from Sunderland to Torness Quay via cargo barge. The barge is expected to arrive on **21st November 2021**, at the earliest.

The components will be transported on the barge, *Terra Marique* (IMO: 9281384), accompanied by a tug; *DMS Condor* (call sign: **2EHT2**).

Area of Operations

Mariners are advised that the *Terra Marique* and associated tug will arrive at the Torness Power Station quay as shown in Figure 1 and the coordinates in Table 1, from Sunderland.

Please be aware that by virtue of its mode of operation and the equipment deployed, the *Terra Marique* and *DMS Condor* will at times be Restricted in Ability to Manoeuvre as defined under COLREGS (International Regulations for Preventing Collisions at Sea 1972, Rule 3). Masters of vessels are therefore requested to maintain a minimum safe distance from the vessel of 500 metres when showing the appropriate shapes and lights.

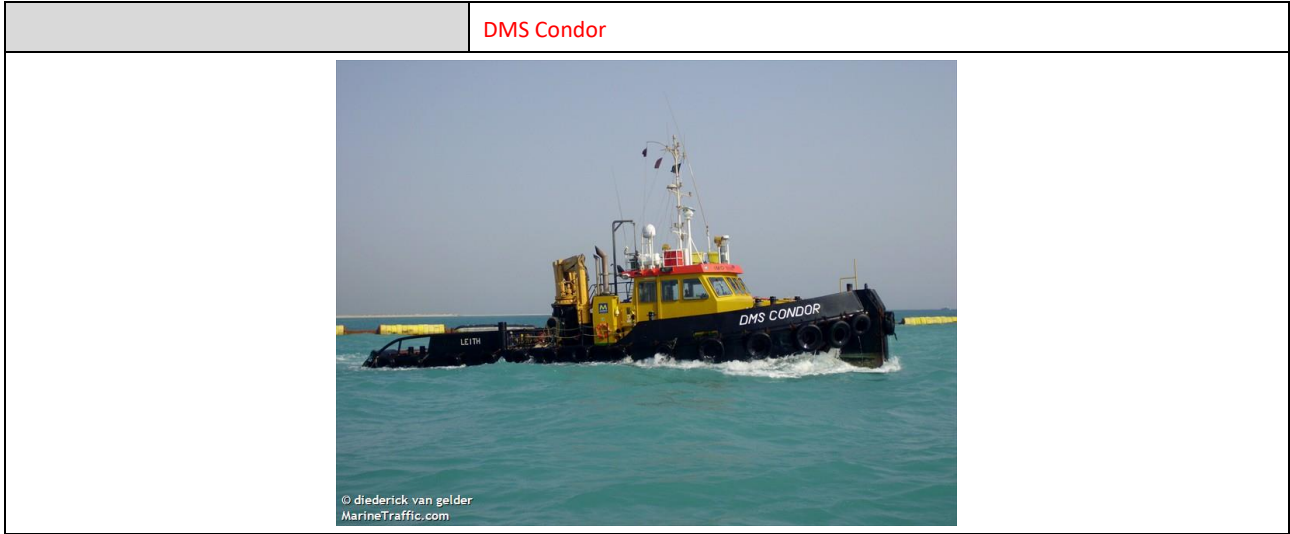
