Mariners are advised that SFF Services Limited will be undertaking the second phase of over-trawl trials on behalf of Neart na Gaoithe Offshore Wind, within the boundaries of the export cable corridor. The trials will commence on 9th February 2022 at the earliest. This phase of the work will take place over a period of up to two days, weather permitting, by the fishing vessel Reliance BF80 (Call sign: MHZZ3).

### **Area of Operations**




Figure 1 - Location of Export Cable Over-trawl trials

Mariners are advised that the Reliance BF80 will transit on a daily basis from Eyemouth to work within the boundaries of the Neart na Gaoithe (NnG) export cable corridor, around two locations; Kilometer Point (KP) 10 and 27, as indicated in Figure 1.
