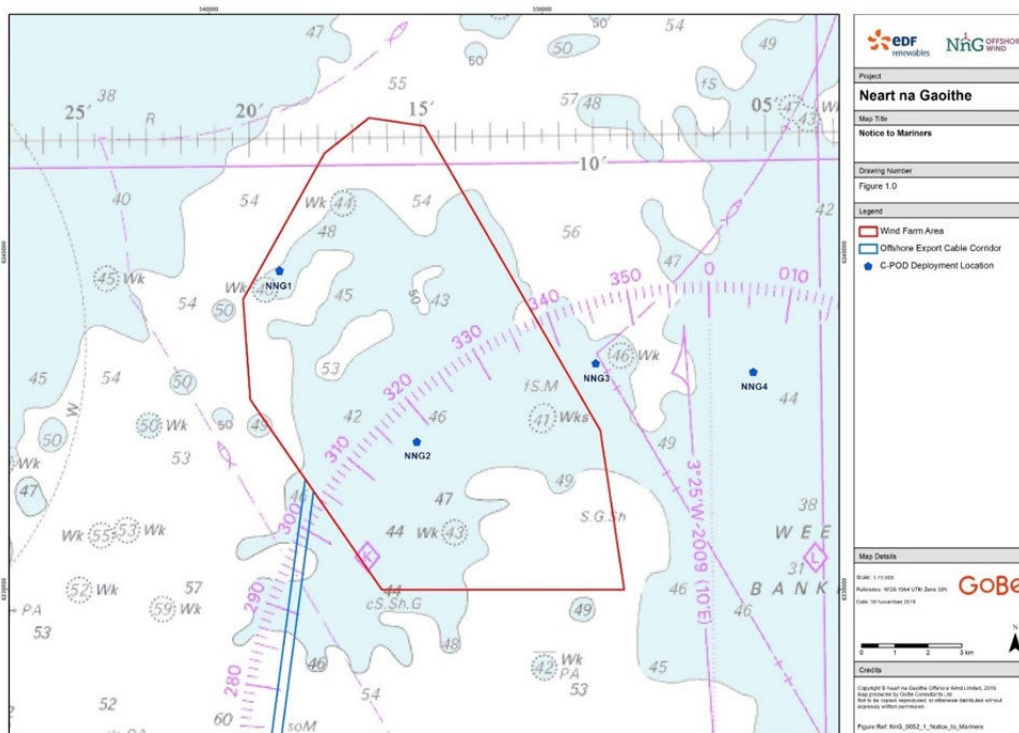


Figure 1 –Location of Acoustic Monitoring Devices

Mariners are advised that maintenance is due to be completed at the four acoustic monitoring devices deployed within the Neart na Gaoithe Wind Farm Area and surrounding waters, shown in Figure 1.

The maintenance will be completed over one day at the earliest the 20th March 2023. This work will be carried out using *Waterfall (call sign 2CBT4)*. The vessel will be working on a 12-hour basis.

Area of Operations

The positions of the four acoustic monitoring devices are indicated by the coordinates in Table 1.

The acoustic monitoring devices are collecting real-time noise measurements for a period of 48 months. The devices will be inspected and maintained at least every four months.
