
# Mariners are advised that maintenance has been completed of the four acoustic monitoring devices deployed within the Neart na Gaoithe Wind Farm Area and surrounding waters, shown in Figure 1.

#### **Area of Operations**

The positions of the four acoustic monitoring devices are indicated by the coordinates in Table 1.

# <u>Schedule</u>

The acoustic monitoring devices are collecting real-time noise measurements for a period of 48 months. The devices will be inspected and maintained at least every four months.
