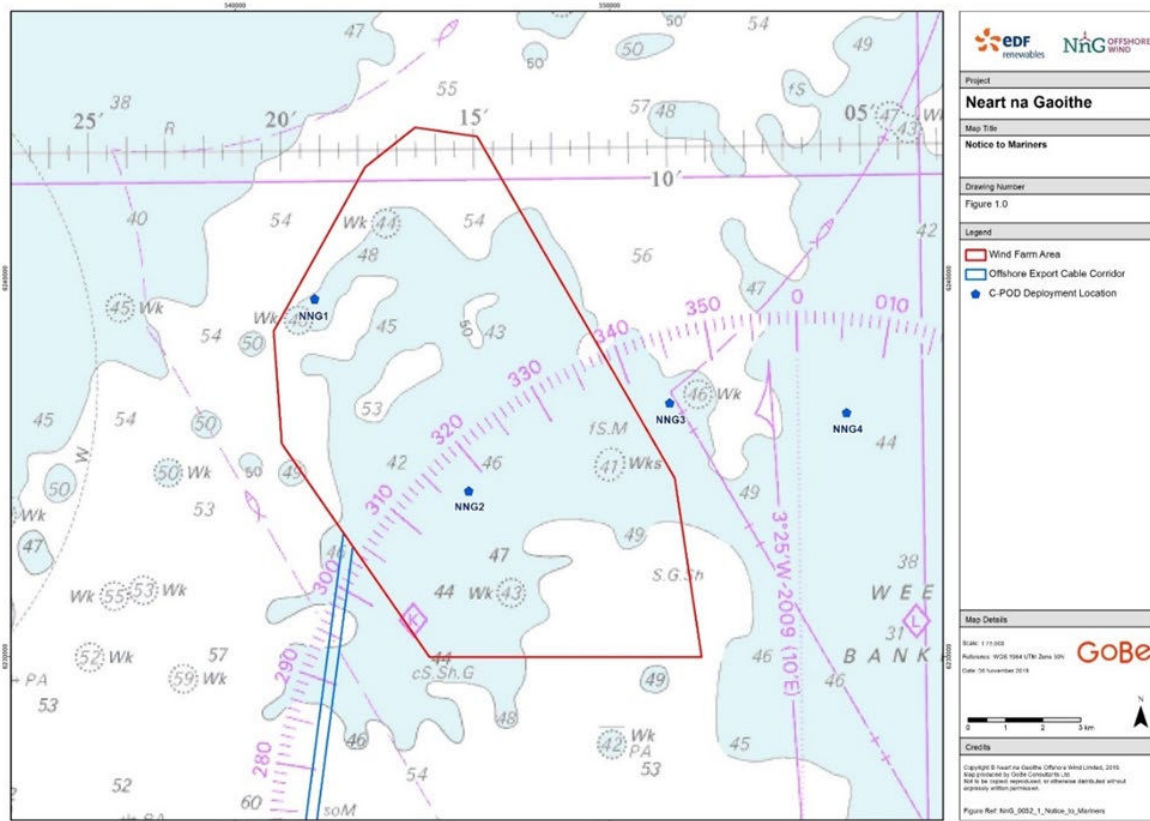


Figure 1 –Location of Acoustic Monitoring Devices

Mariners are advised that maintenance has been completed of the four acoustic monitoring devices deployed within the Neart na Gaoithe Wind Farm Area and surrounding waters, shown in Figure 1.

Area of Operations

The positions of the four acoustic monitoring devices are indicated by the coordinates in Table 1.
