Mariners are advised that Neart na Gaoithe Offshore Wind Farm Limited (NnGOWL) that commissioning works of the North and South offshore substation is currently ongoing within the NnG Wind Farm Area.

Personnel are being transported to and from the North and South OSS topside by Crew Transfer Vessels (CTV); the *Rix Lion* (call sign: 2HOH3) and the *Green Storm* vessel (call sign: 2EXU3) presently.

The MCS Kaver (call sign: 2GMB8) will be leaving NnG site due to windscreen damages on the vessel and will be replaced by the MCS Sirocco (call sign: 2FFP4) on the 5th of April 2024, at the earliest. The CF Explorer vessel (call sign: 5BKK5) and the MCS Sirocco will be providing additional commissioning support for the ongoing work son both OSS South and OSS North until the end of summer 2024.

In addition, the project has also onboarded an additional CTV, MCS Boreas (call sign: 2GDR8) to provide general construction support from the 28th of February 2024.

Area of Operations




Figure 1 – NnG Offshore Wind Farm Area

Mariners are advised that commissioning works are currently ongoing on both the North and South offshore substation topside, within the NnG Wind Farm Area, shown in Figure 1.
