Mariners are advised that Neart na Gaoithe Offshore Wind Farm Limited (NnGOWL) that commissioning works of the North and South offshore substation is currently ongoing within the NnG Wind Farm Area. The OSS South transformer installation works will commence on the 22nd of April, at the earliest.

Crew Transfer Vessels (CTV); the *Rix Lion* (call sign: 2HOH3) and the *Green Storm* vessel (call sign: 2EXU3) has left NnG site and is replaced by MCS Sirocco vessel (call sign: 2FFP4) from the 20th of May 2024. The MCS Sirocco act as CTV for personnel transport to and from the North and South OSS topside.

The Forth Engineer (call sign: 2HAL3) and the MCS Kaver will be providing commissioning support for the ongoing work son both OSS South and OSS North until the end of summer 2024.

Upon completion of the OSS South transformer installation, the HEA Hyra vessel will leave the NnG site on the 27th of April 2024, at the earliest – weather dependant. Commissioning testing will commence soon after installation works and inspections are complete.

In addition, the project has also onboarded an additional CTV, MCS Boreas (call sign: 2GDR8) to provide general construction support from the 28th of February 2024.

Vessel details and contact details have updated in the table below.

Area of Operations




Figure 1 – NnG Offshore Wind Farm Area

Mariners are advised that commissioning works are currently ongoing on both the North and South offshore substation topside, within the NnG Wind Farm Area, shown in Figure 1.
