


Figure 1 – Location of acoustic mooring devices

Mariners are advised that maintenance is due to be completed at the four acoustic monitoring devices deployed within the Neart na Gaoithe Wind Farm Area and surrounding waters, shown in Figure 1.

The maintenance will be completed over one day at the earliest from the 26th June 2024. This work will be carried out using Green Quest (*call sign 2DYY8*). The vessel will be working on a 12-hour basis.

Area of Operations

The positions of the four acoustic monitoring devices are indicated by the coordinates in Table 1.
