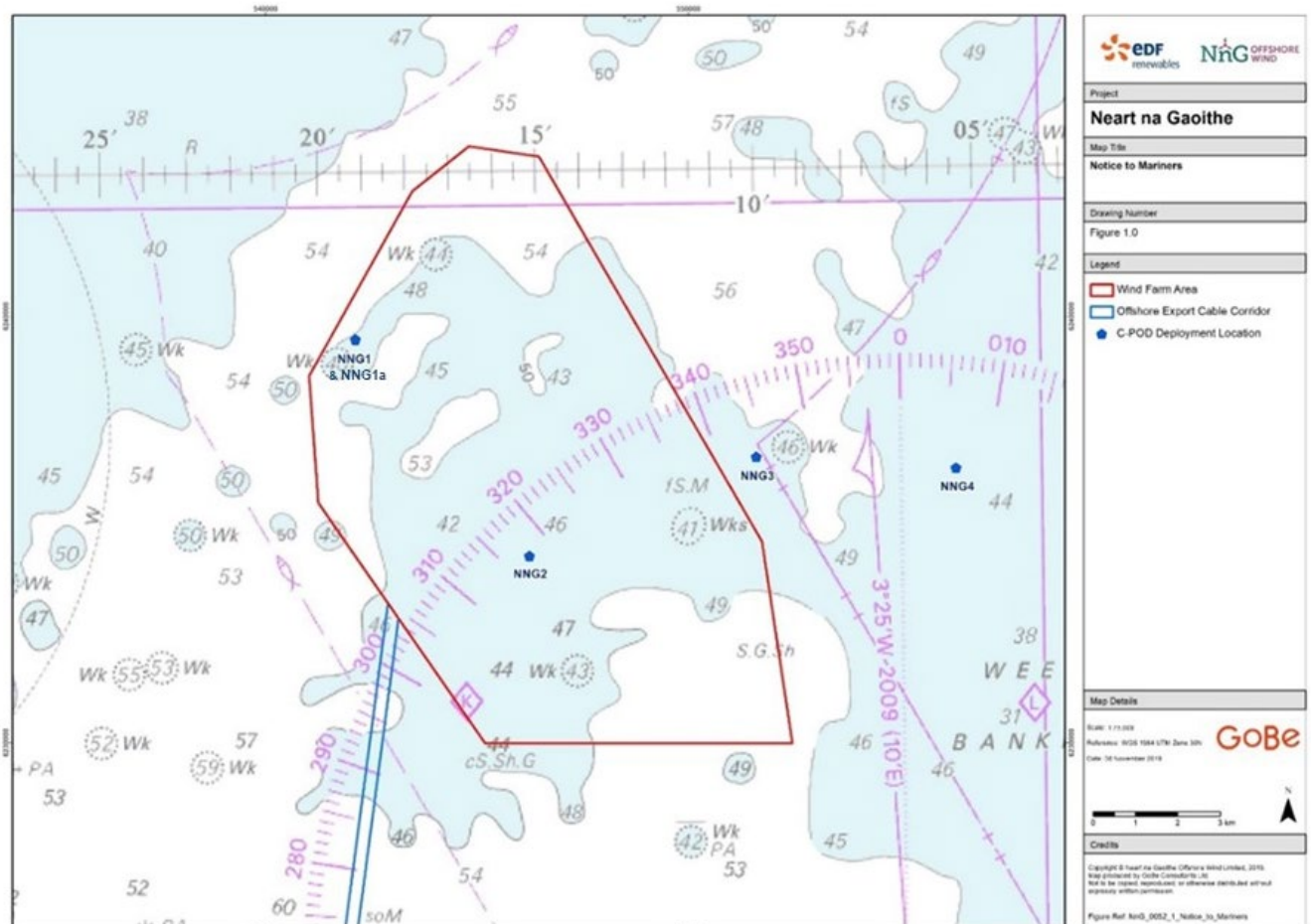


Figure 1 – Location of acoustic mooring devices

Mariners are advised that maintenance has been completed of the acoustic monitoring. As of the 30th June, there are five acoustic moorings devices located within the Neart na Gaoithe Wind Farm Area and surrounding waters, as shown in Figure 1.

Area of Operations

The acoustic monitoring devices are collecting real-time noise measurements for a period of 48 months. The devices will be inspected and maintained at least every four months.
