Mariners are advised that Neart na Gaoithe Offshore Wind Farm Limited (NnGOWL) has commenced the installation of offshore wind turbines within the Neart Na Gaoithe (NnG) Wind Farm Area. Offshore Wind Turbine commissioning works commenced in March 2024 and is currently ongoing.

35 wind turbines (+ 3 partially installed turbines) have been installed onto pre-installed jackets in the NnG Wind Farm Area. The turbines were brought to site and installed from the Port of Dundee by the *Blue Tern* vessel (call sign: 9HA5208) and WTG commissioning was carried out using the *HST Swansea* call sign (MNGM8) that has been replaced by the *HST Millie* vessel (call sign: MOAN6) from the 16th September 2023 at the earliest.

The *Farra Ciara* (call sign: MKPT9) and *Farra Emer* (call sign: MNDD6) CTVs have left NnG site on the 11th of May 2024. HST Padstow vessel (call sign: MORL8) will be replaced by the NOS Impresser vessel (call sign) on the 1st of September, at the earliest. The NOS Impresser will continue providing crew transfer support to the work package. **A SOV, *Vestri Enabler* (call sign: LAQL8) will be supporting the campaign from the 23rd of November, at the earliest.**

The *Manor Victor* CTV (call sign: MLR19) will be supporting the refuelling works for the WTG temporary generators from the 9th November at the earliest. The *Windcat 16* (call sign: 2BOO8) has replaced the *Windcat 19* (call sign: 2ATD3). The *Windcat 16* (call sign: 2BOO8) and *Windcat 20* (call sign: 2CQX8) CTVs are assisting with rectification works on the turbine platforms. The *Manor Vulcan* (call sign: MLRK6) vessel will be replaced by the Manor Venture vessel for additional refuelling support from the 28th of August 2024 to 21st September 2024. The Manor Vulcan vessel will return on the 22nd of September 2024 to replace the Manor Victor vessel.

The NOS Completer (call sign: 2DLB8) has been replaced by the NOS Seeker (call sign: OUWJ2) from the 4th of July 2024. The NOS Seeker has left NnG site on the 9th of July 2024 and will be replaced by the Farra Lark (call sign: MMAC6) on the 20th of July 2024, at the earliest.

Area of Operations

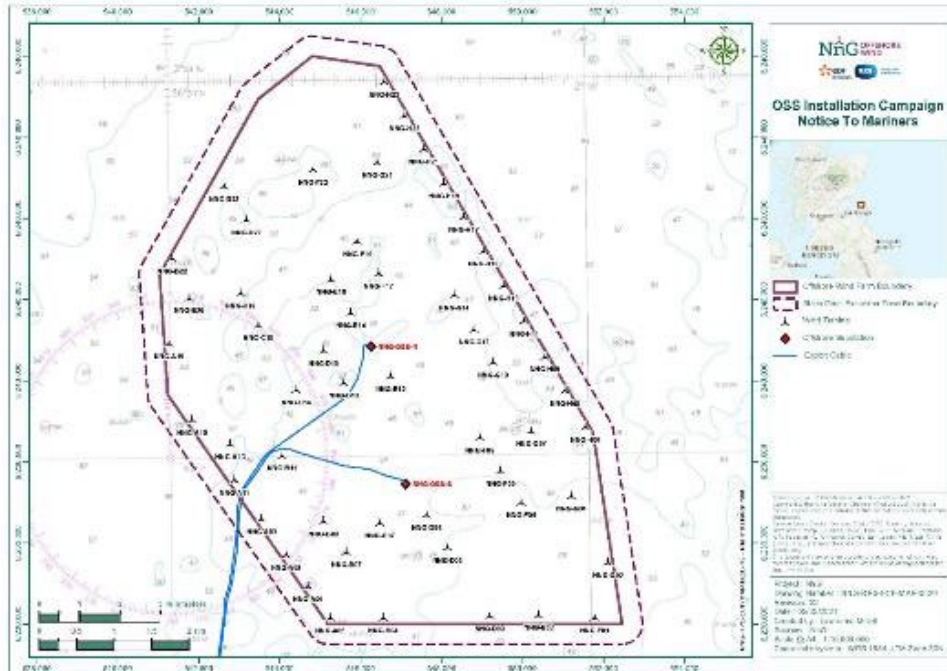


Figure 1 – NnG Offshore Wind Farm Area

Mariners are advised that the aforementioned vessels will be working within the NnG Wind Farm Area, shown in Figure 1.

All vessels are requested to remain at least 500 metres away from all work vessels and static fishing gear is requested to be removed from the exclusion area shown in Figure 1 and Table 1.

Vessels over 15m are also requested to have AIS turned on and detectable when in the vicinity of construction works.

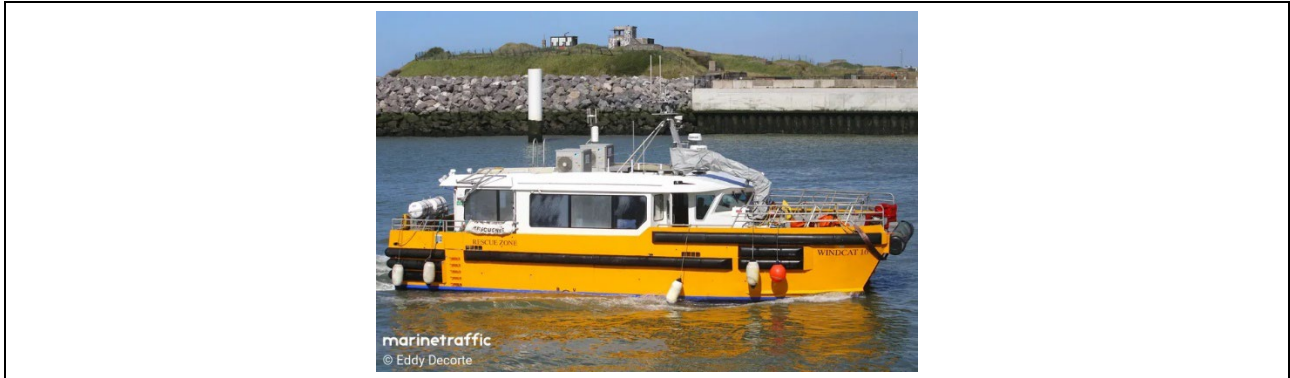
